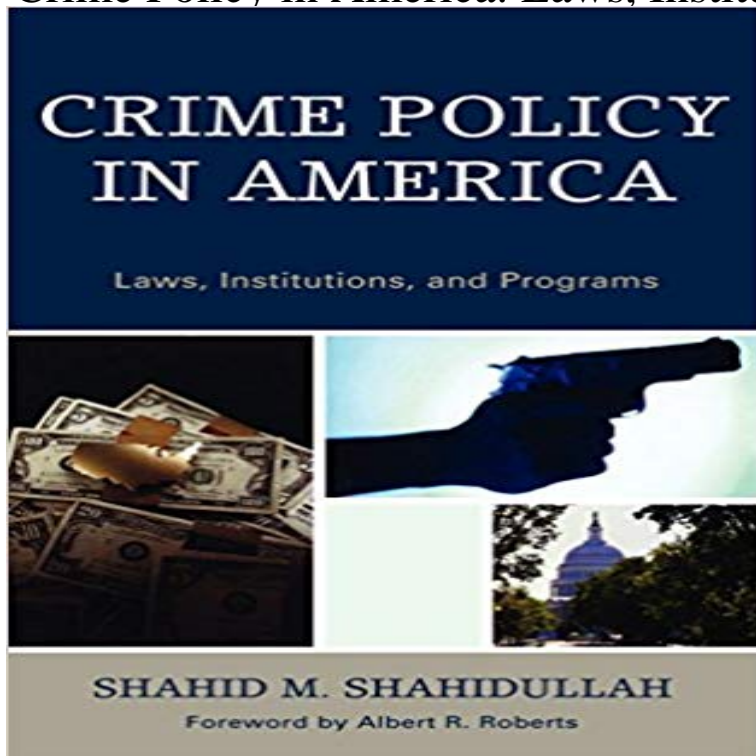


## Crime Policy in America: Laws, Institutions, and Programs
