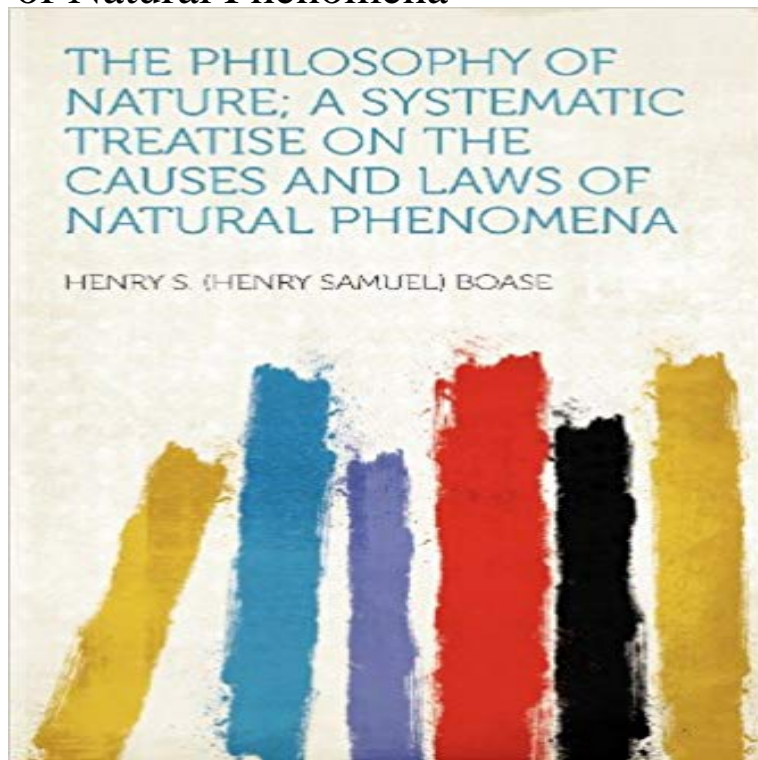


# The Philosophy of Nature; a Systematic Treatise on the Causes and Laws of Natural Phenomena
